In continuation of the Court's earlier Employment Notification No. 6256–RG. Dated, Calcutta, the 6th July, 2011 and also corrigendum published related thereto under Notification nos. 6343-RG dated 7th July, 2011, 6402-RG dated 11th July, 2011 and 6535-RG dated 16th July, 2011, this is for general information to all concerned that the vacancies in respect of different posts for the District Paschim Medinipur is to be read as follows instead of as inadvertently mentioned in the aforesaid Employment Notification.
