The Hon'ble the Chief Justice, High Court, Calcutta has further been pleased to declare that the officers and members of the staff of the High Court/Subordinate Courts who are residents and bonafide voters in a particular District/Parliamentary Constituency/Assembly Constituency where polling will be held on a particular day but serve in the High Court/Subordinate Courts where polling will not be held on the same day, may be permitted to exercise their franchise on the respective day of poll of that particular District/Parliamentary Constituency/Assembly Constituency by way of granting special leave, if applied for in writing with documentary evidence.
