Sub: Filling up the post of Presiding Officer of Central Government Industrial Tribunal-cum-Labour Court, New Delhi-II, Cheńnai, Ernakulam, Chandigarh-II, Jabalpur, Jaipur, Dhanbad-I and Dhanbad-II - regarding.

Sir,

I am directed to say that the post of Presiding Officer of Central Government Industrial Tribunal-cum-Labour Court (CGIT-cum-LC) at New Delhi-II, Chennai, Ernakulam, Chandigarh-II; Jabalpur, Jaipur, Dhanbad-I and Dhanbad-II are to be filled up shortly in terms of provisions of The Tribunal, Appellate Tribunal and other Authorities (Qualifications, Experience, and other Conditions of Service of Members) Rules, 2017. A copy of Notification of the said rules i.e. No. G.S.R. 514 (E), dated .01.06.2017 is enclosed as **Annexure-I**.

2. According to these provisions, a person shall not be qualified for appointment as Presiding Officer, unless he/she-

(a) is, or has been, or is qualified to be, a Judge of a High Court; or

- (b) he has, for a period of not less than three-years, been a District Judge or an Additional District Judge; or
- (c) is a person of ability, integrity and standing, and having special knowledge of, and professional experience of not less than twenty years in economics, business, commerce, law, finance, management, industry, public affairs, administration, labour relations, industrial disputes or any other matter which in the opinion of the Central Government is useful to the Industrial Tribunal.

3. The terms and conditions of presiding officers so appointed will be as per Rules indicated under para 1 above.

4. Earlier vacancy circulars 21.11.2016 (in r/o CGIT-cum-LCs Jabalpur, New Delhi-II and Chennai), 19.12.2016 (in r/o CGIT-cum-LC, Ernakulum), 01.12.2016 (in r/o Chandigarh-II), 02.01.2017(in r/o Jaipur), 08.03.2017 (in r/o Dhanbad-I) and 08/12.05.2017 (in r/o of Dhanbad-II) for filling up vacancies of Presiding Officers may be treated as **cancelled**. Those who had applied in response to the said earlier vacancy circulars **need to apply afresh in response to this vacancy circular**.

It is requested that a panel of names of applicants who are willing to be appointed as Presiding Officer of CGIT-cum-LCs at New Delhi-II, Chennal, Ernakulam, Chandigarh-II, Jabalpur, Jaipur, Dhanbad-I and Dhanbad-II and fulfill the eligibility conditions as per Notification No. G.S.R. 514 (E), dated 01.06.2017, may please be sent to this Ministry within a period of one month from the date of issue of this letter.

6. A set of three (03) proformae (Annexure-II, III & IV) are to be appended to <u>each</u> application. A check-list (copy placed at Annexure-II regarding the documents/copies enclosed may be sent with <u>each</u> application. The Bio-Data of <u>each</u> of the officers may be furnished in the proforma placed at Annexure-III to be filled in by the concerned officer and <u>attested by the concerned Registrar</u> <u>General.</u> The nomination of <u>each</u> of the officers may be forwarded along with an abstract of ACRs (if applicable to the officer) of the last five years duly certified in the proforma placed at Annexure-IV, along with the ACR dossiers and vigilance clearance (if applicable to the officer).

7. It is requested that a panel of names of judicial officers who fulfill the requirements, as mentioned above and are willing to take up the assignment on terms and conditions mentioned in the enclosed Rules (Annexure-I) may please be furnished to this Ministry along with the proformae (Annexure-II, III & IV).

8. Nominations with complete proformae and verified copies of ACR dossiers (if applicable) only will be entertained by the Ministry.

9. This Circular may be given wide publicity so that sufficiently large number of candidates apply for the post.
