The Ld. Advocates are requested to join virtual hearing utilizing the Zoom Meeting ID and Passcode of the respective Court received through email. The Ld. Advocate shall vacate the KIOSK immediately after his/her matter gets over providing access to the next one.

The said KIOSKS will be functional on and from Thursday, the 20th January, 2022, until further orders.
