Pursuant to the direction of The Hon'ble The Chief Justice dated 8<sup>th</sup> December, 2021 His Lordship has been pleased to direct as follows:

"Any matter which has been released by the Hon'ble Court shall be immediately sent to the concerned department and the department shall place the file before the Secretariat of the Hon'ble the Chief Justice within 24 hours or by the next working day, whichever is earlier, for appropriate order, excluding the matter which has been released for lack of determination, such matter shall be placed by the concerned department forthwith to the appropriate Hon'ble Bench having determination within 24 hours or by the next working day AND the matter which has been released by the Hon'ble Bench and directed to be placed before the Hon'ble The Chief Justice for appropriate order/assignment, shall be sent to the Secretariat of the Hon'ble the Chief Justice immediately within 24 hours or by the next working day, whichever is earlier".
