- i) From the second paragraph at page no. 2 of the order dated 09.09.2019 it appear that the defendant willing to vacate the suit premises in favour of defendant.
- ii) The chapter mentioned in the first time and first paragraph of page no. 1 of the order sheet dated 09.09.2019 may be clarified.
