If any matter is released by the Division Bench on the ground of Hon'ble Justice Arindam Mukherjee, the same shall be heard by the Division Bench comprising Hon'ble Justice Biswajit Basu and Hon'ble Justice Biswaroop Chowdhury. Similarly, if any matter is released by the Division Bench on the ground of Hon'ble Justice Biswaroop Chowdhury, the same shall be heard by a Division Bench comprising Hon'ble Justice Arindam Mukherjee and Hon'ble Justice Siddhartha Roy Chowdhury without calling for any order of assignment.
- 2. If any matter is released by SB-I, the same shall be heard by SB-II, if any matter is released by SB-II, the same shall be heard by SB-I and if any matter is released by SB-III, the same shall be heard by SB-I without calling for any order of assignment.
