## CORRIGENDUM

**(In connection with Employment Notification No.01-2024, dated Bankura, the 22<sup>nd</sup> Day of May, 2024)**

In continuation and partial modification of Employment Notification No 01-2024 dated 22.05.2024, the reserved vacancies under UR, UR(EC) and UR (Ex-Serviceman) in the Employment Notification No 01-2024 dated 22.05.2024 are hereby modified to accommodate the reservation for **Economically Weaker Section (EWS)** candidates as per No. 325-PAR(AR)/3P-1/2019 dated 09.07.2019 issued by the Personnel and Administrative Reforms Department, Government of West Bengal read with Gazette Notification No 18-Emp (EC)/LABR-27011(20)/1/2020-EC dated 07.02.2023, keeping the reserved vacancies for other categories unchanged in the following manner :-

The reservation for the EWS Candidates will be guided by the Gazette Notification No. 18-Emp (EC)/LABR-27011(20)/1/2020-EC dated 07.02.2023 read with No. 325-PAR(AR)/3P-1/2019 dated 09.07.2019 issued by the Personnel and Administrative Reforms Department, Government of West Bengal.

As there is no vacancy for UR (EC) category for the post of Upper Division Clerk and Seal Bailiff after inclusion of EWS category, the candidates already applied for these posts are permitted to switch over to other categories in the same post. For switching over to EWS or other category, the concerned candidates are directed to contact through the email [bankuracrtews@gmail.com](mailto:bankuracrtews@gmail.com) from their registered email ID, with supporting documents. If any candidate does not modify the application form for UR (EC) category for the post of Upper Division Clerk and Seal Bailiff, his/her candidature will be treated as cancelled and the application fees shall be refunded.

In this respect, the candidates, who have already submitted their online application in the portal, and who belong to EWS category are permitted to edit their application form to the category of EWS in the same post. For such edit, the concerned candidates are directed to contact through the email ID [bankuracrtews@gmail.com](mailto:bankuracrtews@gmail.com) from their registered email ID with supporting documents.
