**They are also requested to bring their Original call letter for Personality test/ Viva -Voce Test as well as admit card for Preliminary Examination (held on 17.03.2019) and Original photo identity proof (i.e. Voter Card and Adhar Card etc. ), Original age Proof ((Like Birth Certificate, Admit Card of Madhyamik Examination etc. ) and also all Original Testimonials regarding their educational qualification as well as Experience Certificate, Caste Certificate, EC Category Certificate, if any for their documents verification along with self- attested photocopies of the aforesaid documents . They have to report at the English Department, District Judge's Court, Hooghly positively within 12.00 Noon on the date as mentioned against their name for Personality test/ Viva -Voce Test. If any candidate fails to submit requisite documents as per his/her application, his/her candidature will be cancelled at the time of Verification of documents.**

Call letters for the Personality test/ Viva -Voce Test will be despatched very shortly. It is pertinent to mention here that the candidates has to log in by entering his/her application number and password (Generated at the first time of Registration) and then he/she will be able to download his/her admit card.
