- 2) The Reporting Time of the Candidates at the Interview Venue will be at **10:00 A.M.**
- 3) Candidates are requested to note the Date of Interview against their names in the List.
- 4) CANDIDATES MUST BRING THE COUNTERPARTS OF THEIR ADMIT CARDS RETAINED BY THEM AFTER THE EXAMINATIONS HELD ON 19.01.2020 & 25.01.2020.
- 5) Candidates must bring at least one of the following Original (not photocopy or scanned copy) valid photo identification proofs (Passport, PAN Card, Voter Identity Card, Aadhar-UID Card, Driving Licence) at the Interview Venue with a photocopy thereof for verification by Venue Officials.
- 6) Candidates will be permitted to appear at the Interview ONLY after their credentials are verified by Venue officials.
- 7) Candidates are advised to reach the Interview Venue positively before the scheduled Reporting Time noted above. No candidate shall be allowed to report at the Interview Venue after 15 minutes of the scheduled Reporting Time.
