As per notifications numbers ... RC-01 of 2019 Dated: 19.12.2019; R-05/2021, dated 07.10.2021; R-08/2021, dated 14.10.2021 and R-14/2021, dated 29.11.2021, three stage examination held for the Category, English Stenographers (Group-B) comprised of MCQ Paper of 100 marks (03.10.2021), Written Paper (Dictation ,Transcription and Typing in Computer) of 300 marks (13.11.2021) and Personality-cum-Computer Operation test of 30 marks (15.12.2021). ** Twelve (12) number of candidates did not turn up for their Viva voce (Personality Test) though intimated properly like any other candidate of this Category. As such we have mentioned their marks secured by them in MCQ Paper (held on 03.10.2021).

*** Five (05) number of candidates who were caught red handed while taking instructions/ answers on their mobile phones inside the examination hall and during the examination on 03.10.2021 were expelled immediately. F.I.Rs were lodged against them and very recently they have surrendered before the Court. Their names are :

**** Seven (07) number of candidates who scored very handsomely in MCQ Paper, failed miserably in their Personality Test and scored “zero” only. Most of them even could not open and shut down the Computer set as well . In order to justify the marks secured by them in MCQ Paper, we put questions to them from their ‘Series’ of Question booklet by showing it to them but they could not answer a single question there from. For the peculiar and agonizing situation, resolution had to be passed by the Recruitment Committee along with the Interview Board on 14.12.2021 and unanimously it was decided in writing to declare such candidates as “**not qualified**” being unsuccessful Candidates. Recruitment Committee has the right to take decisions which it thinks and decides as fit and proper (RC-01/2019: Dated: 19.12.2019) in any given situation.

***** The Courts of Kalimpong Judgeship will remain closed from 25.12.2021 to 26.01.2022 for winter vacation.

***** There were only two vacancies in UR Category but apart from Abhijeet Chettri, no one secure marks more than Nidhi Adhikary, hence, he has been selected as an UR Category Candidate, though he originally belongs to SC Category.

As Md. Shahid Munna scored 39.33 in his original category of OBC-A-EC but better than any other candidate in UR-EC Category, he has been placed at rank-1 in the category of UR-EC instead of its original category.

As such, candidates from serial no. 1 to 6 and 7 to 12 are directed to appear on **28.01.2022 & 29.01.2022** along with all original testimonials, caste certificates, certificates regarding ‘Exempted Category’ etc. and report to the English Office at 11.30 A.M. They are directed to bring one set of Photostat copies of all their original testimonials.
