3.	New hostel(one room)	700/-	
4.	Old hostel(one room)	500/-	

2- Apart from the above, a well equipped Auditorium having capacity of 300 persons at a time is also available for organizing Educational, Social and Cultural events on payment basis and the details thereof may be taken from website of this Academy. The check out time for all the above mentioned accommodation shall be 24 hours.
