The Hon'ble Justice Moushumi Bhattacharya, the Hon'ble Justice Bibek Chaudhuri and the Hon'ble Justice Md. Nizamuddin will hold the Circuit Bench at Jalpaiguri on and from Monday, the 1st February, 2021 till Friday, the 12th February, 2021 (both days inclusive), in the following manner:

Note: Commencement of sittings of the Benches will be decided by the Hon'ble Judges holding the Circuit Bench.

If any matter is released by the Division Bench of which Hon'ble Justice Moushumi Bhattacharya is a member, on the ground of Hon'ble Justice Moushumi Bhattacharya, the same shall be heard by a Division Bench comprising Hon'ble Justice Bibek Chaudhuri and Hon'ble Justice Md. Nizamuddin. Similarly, if any matter is released by the Division Bench of which Hon'ble Justice Md. Nizamuddin is a member, on the ground of Justice Md. Nizamuddin the same shall be heard by a Division Bench comprising of Hon'ble Justice Moushumi Bhattacharya and Hon'ble Justice Bibek Chaudhuri.

Appeals against the order of Hon'ble Justice Moushumi Bhattacharya shall be heard by the Division Bench comprising of Hon'ble Justice Bibek Chaudhuri and Hon'ble Justice Md. Nizamuddin. Similarly, appeals against the order of Hon'ble Justice Md. Nizamuddin shall be heard by the Division Bench comprising of Hon'ble Justice Moushumi Bhattacharya and Hon'ble Justice Bibek Chaudhuri.

If any matter is released by a Single Bench, the same shall be heard by the other available Single Bench.

The directions issued vide Notification No.4286-RG dated 27th November, 2020 shall be followed as far as practicable.

The directions issued vide Notification No. 111-RG dated 8th January, 2021 shall be followed strictly.
