ON MONDAY, OCTOBER 11, 2021 AT 11:00 A.M. IN

- 11:00 A.M. The Hon'ble Judges in robes assemble in the Judges' Lounge.
- 11:05 A.M. The Hon'ble Chief Justice designate arrives and is received by the Hon'ble Mr. Justice I. P. Mukerji.
- 11:10 A.M. The Hon'ble Governor of West Bengal arrives at the High Court at Calcutta. The Hon'ble Mr. Justice I. P. Mukerji receives the Hon'ble Governor and accompanies His Excellency to the first floor by the Judges' Lift. The Hon'ble Chief Justice designate receives the Hon'ble Governor on the first floor at the alighting point.
- 11:15 A.M. The Hon'ble Governor, the Hon'ble Chief Justice designate and the Hon'ble Mr. Justice I. P. Mukerji proceed to the Judges' Lounge.
- 11:20 A.M. The Deputy Sheriff leads the Hon'ble Governor, the Hon'ble Chief Justice designate, the Hon'ble Judges to the Chief Justice's Court Room.
(All present will rise from their seats and remain standing until all the Hon'ble Judges are on the dais and the National Anthem is played).
(The Deputy Sheriff will remain standing on the dais in the last row behind the Hon'ble Judges with the silver oar, mace and sword of Admiralty, holding them vertically).
- 11:25 A.M. The Registrar General will seek permission of His Excellency, the Governor of West Bengal, so that the proceedings may start. Thereafter, with the permission of His Excellency, the Registrar General will read out the notification issued by the Additional Secretary to the Government of India, Ministry of Law & Justice (Department of Justice), New Delhi.
- 11:28 A.M. The Registrar General will request His Excellency, the Governor of West Bengal, to administer oath of office to the Hon'ble Mr. Justice Prakash Shrivastava as the Chief Justice of the Hon'ble High Court at Calcutta.
- 11:30 A.M. The Governor will administer oath of office to the Hon'ble Mr. Justice Prakash Shrivastava as the Chief Justice of the High Court at Calcutta.
(All present will remain standing so long as the oath is administered and taken.)
- 11:35 A.M. Felicitation Speech by (a) Learned Advocate General of West Bengal, (b) Learned Addl. Solicitor General (c) Chairman, Bar Council of West Bengal, (d) The President/Vice-President/Secretary, Bar Library Club, (e) Joint Special Officer, Bar Association and (e) The President/Vice President/Secretary, Incorporated Law Society.
(three minutes each).
- 11:50 A.M. In reply, address by the Hon'ble Chief Justice, High Court, Calcutta.
- 11:53 A.M. With the permission of His Excellency, the Governor of West Bengal, the Registrar General will declare conclusion of the ceremony. All present will rise from their seats and National Anthem will be played.
- 11:55 A.M. The Deputy Sheriff will lead His Excellency the Hon'ble Governor, the Hon'ble Chief Justice and the Hon'ble Judges to the Judges' Lounge.
- 11:56 A.M. All Guests and Invitees will join the Hon'ble Chief Justice for Tea.
- 12:10 P.M. The Hon'ble Governor will leave the High Court. (Hon'ble Governor will be seen off by the Hon'ble Chief Justice and the Registry Officials at the Judges' Gate.)
