MERIT WISE RESULT OF THE NORMAL PROMOTION - 2021 TO THE CADRE OF DISTRICT JUDGE (ENTRY LEVEL)

The first 10 (ten) Officers of this Merit-wise list are selected and recommended for appointment to the post of District Judge (Entry Level) by way of Normal Promotion out of 11 vacancies declared for the year 2021, keeping 1 (one) vacancy reserved for the time being.

Further recommendation for appointment, if any, from the merit list shall be guided by the Order/outcome on the application bearing no. IA No. 93974/2019 filed by this Hon'ble Court before the Hon'ble Supreme Court of India and decision of the Administrative Committee of the Hon'ble Court on the ACR grading of Sri Rajesh Tamang, at any time before next declaration of vacancy. Revised Merit List will accordingly be declared in due course.

Mere empanelment, however, shall not create any right whatsoever in favour of the officers appearing in the merit list for getting promotion.
