The Revised Merit List of the selection process for promotion to the cadre of Civil Judge (Senior Division)/CJM from amongst the eligible officers in the cadre of Civil Judge (Junior Division)/Judicial Magistrate of the West Bengal Judicial Service for the year 2021.

The first 20 (twenty) Officers from this Merit List (From Md. Mohibulla to Smt. Payal Banerjee-II) had already been recommended for promotion in the cadre of Civil Judge (Senior Division)/CJM towards filing up of 21 vacancies mentioned in Court's Notification No. 3813-R(JS) dated 08.09.2021 for the year 2021. Sri Indrajit Deb, ranked 21st of this revised merit list is further recommended for promotion to the cadre of Civil Judge (Senior Division) against one vacancy which was kept reserved.

Smt. Shivi Shrivastava is not found suitable for promotion in view of the number of days of leave availed of by her exceeding the limit of Leave at her credit while Sri Indraneel Chakraborty is also not found suitable for promotion pending certain proceeding against him.

Mere empanelment does not create any right for appointment.
