In terms of the Court's Notification No. 695-RG dated 21<sup>st</sup> February, 2018 and pursuant to Notification No. 2944-R (Recruitment) dated 2<sup>nd</sup> July, 2018 for filling up the 42 (forty two) vacancies in the post of P.A./ Stenographer Grade-C, 2018 in the Appellate Side, High Court, Calcutta, 2 (two) lists, **List-A** and **List-B** are published containing the names, Roll Nos. and Category of the selected candidates.

The candidates whose names are appearing in List-A and List-B, annexed hereto, are hereby requested to report at the Office of the Deputy Registrar (Administration), Appellate Side, located at the ground floor, Main Building at the High Court, Calcutta on 20.07.2018 (Friday) and 24.07.2018 (Tuesday) at 10:30 A.M. **respectively** with the following documents **in original** for the purpose of the verification of the documents:

- i) Admit Card of the Written Test as was issued by the High Court for this examination;
- ii) Photo Identity Proof (Aadhaar Card/ PAN Card/ Driving Licence/ Bank Passbook with Photograph etc.);
- iii) Documents pertaining to the age proof of the candidate;
- iv) Documents pertaining to educational qualifications;
- v) Documents pertaining to Short Hand and Type Writing Skill (if any);
- vi) Caste Certificate (if applicable);
- vii) Eligible Certificate for the Meritorious Sports Person (MSP) candidates as per the Notification No. 695-RG dated 21<sup>st</sup> February, 2018;
- viii) Necessary Certificate for persons with disabilities (PWD) candidates as per the Notification No. 695-RG dated 21<sup>st</sup> February, 2018;

It is hereby clearly mentioned that the expenses to be incurred for the medical examination necessitated in respect of eventual authentication on the format of the Medical Certificate, to be submitted by the candidate at the time of verification of documents, by a competent medical officer of any Government hospital and the travelling expenses for the purpose of verification on the above dates shall be borne by the candidates.

Independent of the instant Notification, candidates selected are being communicated individually through letter by speed post, with necessary documents, intimating the date, time and venue for verification of documents and also for furnishing undertaking.

It is also made clear that the appointment shall be given to the candidates, if found otherwise eligible for the purpose, only on submission of an undertaking, to be furnished at the time of verification of documents, to the effect that he/she shall abide by all the conditions regulating his/ her appointment and also that he/she shall accept his/her posting, at the discretion of Hon'ble the Chief Justice, either at the Principal Seat or at the proposed Circuit Bench of this Hon'ble Court in the State of West Bengal.
