For filling up the 99 existing and expeted vacancies {General (Unreserved) – 61; Scheduled Caste – 22, Scheduled Tribe – 9 and Other Backward Class -7}, in terms of the Employment Notice dated 4<sup>th</sup> February, 2011, corrigendum thereto dated 19-02-11 and also Important Announcement dated 25-03-2011, Written Test – 2012 was held on 22<sup>nd</sup> July, 2012. The Viva-Voce of the selected candidates was also held on 22<sup>nd</sup> and 24<sup>th</sup> to 27<sup>th</sup> Spetember, 2012. On the basis of the marks obtained in the Written Test as well in the Viva-Voce, the following category-wise candidates have been selected, according to merit, for being empanelled for appointment to the post of Group-D in the High Court, Calcutta in the respective categories of posts.

The offer of Appointment will be issued to the empanelled candidates on and from 1<sup>st</sup> October, 2012 to 3<sup>rd</sup> October, 2012 (excepting 2<sup>nd</sup> October, 2012) from 12 noon onwards from the Office of the Deputy Registrar (Administration), High Court, Appellate Side, Calcutta. The empanelled candidates shall have to collect the same along with other relevant papers/forms and a Proforma of Declaration on production of all relevant documents, in original, along with the Admit Card issued for the Written Test and Call Letter issued for the Viva-Voce from Office of the Deputy Registrar (Administation). The selected candidates may accept or refuse the offer, but the same should be communicated to the Deputy Registrar (Administration), High Court, Appellate Side, Calcutta, in writing, positively on or before 3<sup>rd</sup> October, 2012. However, the appointment of the candidates who will not submit, in writing, about the acceptance or refusal of the appointment within 15 days from the date of the receipt of offer of Appointment, stated above, shall be treated as cancelled and in his/her place offer of appointment will be issued to the candidates from the Wait List of the respective category. The Medical Fitness test shall be held in the Calcutta High Court Emergency Medical Unit and the empanelled candidates shall have to appear before the Medical Board by 3<sup>rd</sup> October, 2012 (excepting 2<sup>nd</sup> October, 2012).
