NOTICE

This is hereby notified that total two hundred and sixteen (216) candidates have been selected for appointment in the post of Group-D in the High Court at Calcutta on the Appellate Side and Original Side establishment through the Recruitment Process following the Employment Notification No. 4441 RG dated 28<sup>th</sup> September, 2018.

The appointment shall, in the first instance, be on a purely temporary basis for a period of two years and on completion of the same, they will be on probation for a period of one year, which may be extended for a further period of one year. On satisfactory completion of the period of such probation, they will be confirmed.

However, the appointment shall remain terminable at one month's notice on either side during the period when the same remains temporary.

Offer of Appointment respecting to each candidate has already been sent to them through issuance of Memorandum to that effect detailing therein the condition of service, the pay scale attached to the post and documents required to be submitted by them on certain dates mentioned in the Memorandum.

If they are willing to accept the appointment on the aforesaid terms and conditions, each of the candidates is to report to the office of the undersigned on **16<sup>th</sup> August, 2019; 17<sup>th</sup> August 2019 and 19<sup>th</sup> August, 2019 (as mentioned against the names of each candidates in the list hereinbelow) at 10:30 A.M. sharp** with the Memorandum sent through speed post to each candidate, the Admit Cards of the Written Test and viva-voce test, educational certificates, the Caste Certificate and any other certificate/s, *if applicable*, concerning his/her candidature, all in original. While reporting, he/she is also to submit duly filled up two copies of Police Verification Roll (annexed with the Memorandum sent through speed post) and an affidavit sworn before First Class Judicial Magistrate/ Metropolitan Magistrate affirming that the information submitted through duly filled up Police Verification Roll are true, no criminal case is pending against him/her and in the event information so given are found to be false or misleading to the High Court Administration in any way even after his/her appointment, his/her appointment shall be liable to be cancelled.

**His/her posting may be at the Principal seat of this Hon'ble Court at Kolkata or at the Circuit Bench at Jalpaiguri, at the discretion of the Hon'ble The Chief Justice, and to that effect an undertaking will be obtained from him/her at the time of verification on the above mentioned dates.**

The candidates are required to carry his/her medical test reports in respect of routine blood test (Hb, TC, DC, ESR, Blood Sugar, Urea, Creatinine), eye test, urine test (RE/ME) and chest X- Ray that shall be done at his/her own cost on any day after receipt of the aforementioned Memorandum, from any recognized diagnostic centre, in order to expedite the process.
