No candidate will be allowed to enter into the examination centre without production of his/her **Original Call Letter including the Original Admit Card which was issued in his/her favour for written competitive test (second-phase)**.

The Authority will implement all social distancing (precautionary) measures as per Government guidelines/directives in current scenario of COVID-19 to ensure health & safety of the candidates on the dates of Viva-voce test. No Travelling Allowance (TA) will be paid to the candidates for their appearance before Viva-voce test.
