- Candidate must submit his/her Shorthand book (or used portion thereof) after completion of transcription-phase along 3. with his/her transcribed sheet.

Transcription phase

- 1) This is a model of transcription-sheet, which is to be provided to all the candidates.
- 2) Candidate is to transcribe the dictated passage and to sign (with designation) on the top (space provided) of each and every transcribed-sheet.
- 3) Candidate must put his/her signature at the end of the used portion (last page) of his/her Transcribed-sheet in addition to signing the said page at the top.
- 4) Transcription font must be in <u>Bookman Old Style</u>.
- 5) The font size must be 12
- 6) There must be <u>double line space</u> between two lines.
- 7) There must be at least 1 cm spacing (indent) at the beginning of first line of each paragraph.
- 8) No candidate would be allowed to leave the transcription-room without submitting his/her transcribed-sheet and shorthand
- 9) No candidate will be allowed to consult with other candidate or with any other person during Transcription phase. Violation of this guideline will expose a candidate towards cancellation of his/her candidature.
