In terms of the Employment Notice No. 76-RG, dated 16.01.2014 in connection with Recruitment to the post of Group - D in the High Court at Calcutta and West Bengal Judicial Academy, Kolkata the written test was held on 8<sup>th</sup> June, 2014.
