**Hon'ble Justice Subhendu Samanta (SB-XXIV)**, shall take up the following matters:-

**Hon'ble Justice Ajay Kumar Gupta (SB-XXIX)**, shall take up the following matters:-

\* Appeal related to all Claim Cases including applications connected thereto (Upto 2016).

\* Hearing of Criminal Revisional Applications irrespective of years including applications connected thereto.

All other subject matters, pertaining to the roster/determination of the Hon'ble Judges, which are in effect as on date, shall remain unchanged.
