The Roster/Determination of Appellate Side, Original Side and Commercial Division of this Hon'ble Court, notified vide Notification No. 10404-RG dated 9th November, 2023, is partially modified to the following extent and will take effect from 15th April, 2024:-

Hon'ble Justice Joymalya Bagchi and Hon'ble Justice Gaurang Kanth (DB-VI)

In addition to Their Lordships' present determination, shall take up all matters relating to the designated Courts for MPs / MLAs as per the Judgment dated 9th November, 2023 passed by the Hon'ble Supreme Court of India in WP(C) No. 699 / 2016.

Hon'ble Justice Arindam Mukherjee (SB-V), In addition to His Lordship's present determination, shall take up the following matters:-

* Motion and Hearing of Matters under Article 226 of the Constitution of India relating to service under Group VI and applications connected thereto (From Year 2018 to Year 2022).

Hon'ble Justice Raja Basu Chowdhury (SB-XXII), shall take up the following matters:-

* Motion and Hearing of Matters under Article 226 of the Constitution of India relating to Revenue and Tax Laws (Excluding Land Revenue) under Group-IV including applications connected thereto;

* Motion and Hearing of Matters under Article 226 of the Constitution of India relating to service under Group VI and applications connected thereto (Upto Year 2017).

All other subject matters, pertaining to the roster/determination of the Hon'ble Judges, which are in effect as on date, shall remain unchanged.

The Single Bench numbers of the Hon'ble Judges shall be modified to the following extent:-
