- **2.** The Hon'ble Judges who are sitting in Division Benches may take up matters listed before them in their Single Benches whenever the time permits.
- **3.** Any matter arising out of contempt, review, recall, modification or clarification of order of a Division Bench of which one of the members is not available due to elevation, retirement, transfer or death, shall be heard by the Division Bench of which the available Hon'ble Judge is a member without reference for constitution of a Bench.

In the case where the available Hon'ble Judge is not a member of any Division Bench, the same shall be placed before the Hon'ble the Chief Justice for constitution of a Division Bench with the available Hon'ble Judge. [Order passed on 9<sup>th</sup> March, 2010]

**4.** It is hereby directed that the date of institution of a matter shall be reckoned from the date of its filing. [Order passed on 4<sup>th</sup> March, 2024]
