heard by a Division Bench comprising of Hon'ble Justice Moushumi Bhattacharya and

Hon'ble Justice Saugata Bhattacharyya. Similarly, if any matter is released by the

Division Bench of which Hon'ble Justice Saugata Bhattacharyya is a member, on the

ground of Justice Saugata Bhattacharyya the same shall be heard by a Division Bench

comprising of Hon'ble Justice Rajesh Bindal and Hon'ble Justice Moushumi

Bhattacharya.

• Appeals against the order of Hon'ble Justice Rajesh Bindal shall be heard by the

Division Bench comprising of Hon'ble Justice Moushumi Bhattacharya and Hon'ble

Justice Saugata Bhattacharya. Similarly, appeals against the order of Hon'ble Justice

Saugata Bhattacharyya shall be heard by the Division Bench comprising of Hon'ble

Justice Rajesh Bindal and Hon'ble Justice Moushumi Bhattacharya.

• If any matter is released by a Single Bench, the same shall be heard by the other

available Single Bench.

• The directions issued vide Notification No.4286-RG dated 27th November, 2020 shall be

followed as far as practicable.

The directions issued vide Notification No. 111-RG dated 8th January, 2021 shall be

followed strictly.
