## Circuit Bench of Calcutta High Court at Jalpaiguri

It is hereby notified for information of all concerned that the Hon'ble the Chief Justice, High Court, Calcutta has been pleased to nominate Hon'ble Justice Sabyasachi Bhattacharyya, Hon'ble Justice Subhasis Dasgupta and Hon'ble Justice Kausik Chanda to hold the Circuit Bench at Jalpaiguri on and from Monday, the 15<sup>th</sup> March, 2021 till Friday, the 26<sup>th</sup> March, 2021 (both days inclusive), in the following manner:

Hon'ble Justice Sabyasachi Bhattacharyya And Hon'ble Justice Kausik Chanda	DB - I	Will take all matters required to be taken up by a Division Bench.
Hon'ble Justice Sabyasachi Bhattacharyya	SB - I	Will take up matters required to be taken up by a Single Bench. And Matters relating to Arbitration & Conciliation Act, 1996 including applications connected thereto.
Hon'ble Justice Subhasis Dasgupta	SB – II	Will take up matters required to be taken up by a Single Bench.
Hon'ble Justice Kausik Chanda	SB - III	Will take up matters required to be taken up by a Single Bench.

Note : Commencement of sittings of the Benches will be decided by the Hon'ble Judges holding the Circuit Bench.

The Hon'ble the Chief Justice has further been pleased to pass the following directions:

- If any matter is released by the Division Bench of which Hon'ble Justice Sabyasachi Bhattacharyya is a member, on the ground of Hon'ble Justice Sabyasachi Bhattacharyya, the same shall be heard by a Division Bench comprising Hon'ble Justice Subhasis Dasgupta and Hon'ble Justice Kausik Chanda. Similarly, if any matter is released by the Division Bench of which Hon'ble Justice Kausik Chanda is a member, on the ground of Justice Kausik Chanda the same shall be heard by a Division Bench comprising Hon'ble Justice Sabyasachi Bhattacharyya and Hon'ble Justice Subhasis Dasgupta.
- Appeals against the order of Hon'ble Justice Sabyasachi Bhattacharyya shall be heard by the Division Bench comprising Hon'ble Justice Subhasis Dasgupta and Hon'ble Justice Kausik Chanda. Similarly, appeals against the order of Hon'ble Justice Kausik Chanda shall be heard by the Division Bench comprising Hon'ble Justice Sabyasachi Bhattacharyya and Hon'ble Justice Subhasis Dasgupta.
- If any matter is released by a Single Bench, the same shall be heard by the other available Single Bench.
- The directions issued vide Notification No.4286-RG dated 27<sup>th</sup> November, 2020 shall be followed as far as practicable.
- The directions issued vide Notification No. 111-RG dated 8<sup>th</sup> January, 2021 shall be followed strictly.
- The direction issued vide Notification No. 1083-RG dated 3<sup>rd</sup> March, 2021 shall be followed.
