- 3. Rates should be quoted indicating the total cost and should be inclusive of all additional taxes/charges.
- Willing suppliers submitting Quotations should know that the Hon'ble Court may procure such quantity of listed articles as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Admn.), High Court, A.S.
