- Willing suppliers submitting Quotations should know that the Hon'ble Court may procure  $\underline{\textbf{such quantity of listed}}$ articles as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Assistant Registrar (Court Management), High Court, A.S.
