2. Quotations should be submitted in sealed envelope with **CM/65/24-25** superscripted in it.

- 3. Rates should be quoted indicating price / unit and should be inclusive of all additional taxes/charges.
- 4. Willing suppliers submitting Quotations should know that the Hon'ble Court may procure <u>such</u> <u>quantity of listed articles</u> as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Court Management), High Court, A.S. Calcutta.
- **5.** Suppliers are instructed to mention PAN no. in the quotation and copies of trade license and / or PAN etc is to be submitted as and when the D. R. (Court Management), High Court, A. S., Calcutta may direct.
- **6.** Quotations submitted by such suppliers who are reasonably believed to have either supplied improper articles or engaged in irregular / unethical activities shall not be considered.
