- 3. Rates quoted should be inclusive of all applicable charges, taxes, duties and leveries.
- 4. If the quotation of any supplier, which is not enlisted with this Hon'ble Court, is selected, the concerned supplier may have to submit copies of such documents as Trade License and/or PAN etc. as and when the Accountant, High Court, O.S. Calcutta may direct.
- 5. Conditional quotations will not be considered.
