NOTICE OF CANCELLATION

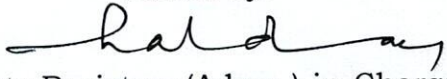

Most respectfully submitted for Your Honour's kind consideration.

It is submitted that the Notice Inviting Quotation (NIQ) bearing No. PPC/CB/JPG/14/N/N.I.Q./19.11.2025 for procurement of 72 (Seventy-two) Nos. HP LaserJet Printer 12-A Cartridges, which has already been uploaded on the Official Website of the Hon'ble Calcutta High Court, contains an inadvertent clerical omission. The due date for submission of quotations was not mentioned in the NIQ.

Due to this omission, this office has received several communications and e-mails from various agencies seeking clarification regarding the last date for submission of quotations. Since the NIQ in its present form is incomplete and may lead to ambiguity or future procedural complications, it is considered appropriate that the said NIQ be cancelled formally, as it has already been circulated in the public domain through the Hon'ble Court's website.

In these circumstances, Your Honour's permission is kindly solicited:

1. To cancel the existing NIQ (No. PPC/CB/JPG/14/N/N.I.Q./19.11.2025) on account of the clerical omission regarding the due date; and
2. To issue and upload a fresh, corrected NIQ incorporating the proper due date and all relevant particulars, upon obtaining Your Honour's approval.

Under the above circumstances, the matter may be placed before Ld. Registrar (Circuit Bench) for kind consideration and passing necessary order(s) to purchase aforesaid articles for the sake of smooth running of this Hon'ble court.
