- 2. Quotations should be submitted in sealed envelope with CM/10/14-15 superscribed in it.
- 3. Rates should be quoted indicating price / unit and should be inclusive of all additional charges.
- 4. Willing suppliers submitting Quotations should know that the Hon'ble Court may procure such quantity of listed articles as it may consider necessary, and that, supply of articles may have to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Admn) High Court, A.S. Calcutta.
- 5. If the Quotations of any suppliers, which is not enlisted with this Hon'ble Court, is selected, the concerned supplier may have to submit copies of such documents as Trade License and / or PAN etc. as and when the D.R. (Admn) High Court, A.S., Calcutta may direct.
