No quotation, even if complete, irrespective of whether hand-delivered or sent by Post etc., will be received after 14-00 hours of 11.10.18.

B. OPENING OF QUOTATION:

1. Quotation, if considered valid and complete, will be opened jointly by Joint Registrar (General Administration-II), A.S and Deputy Registrar (Accounts), A.S, and any subsequent declaration pertaining to the instant '**Notice**' will be published in the same 'Notice Board of the Appellate Side'.
