2. Tenders must be **addressed to Ld Registrar Listing High Court, Calcutta** 'and superscribed **'PPC/ 08/ comp / misc** and submitted in the office of the **Deputy Registrar (Computer) on** or before **03.12.2020**. No quotation, even if complete, irrespective of whether hand-delivered or sent by Post etc., will be received after 16-00 hours of 03.12.2020.

**B. OPENING OF QUOTATION:**

1. Quotation, if considered valid and complete, will be opened jointly by Deputy Registrar Computer and Assistant Registrar Listing any subsequent declaration pertaining to the instant '**Notice**' will be published in the same 'Notice Board of this institution.

**C. GENERAL:**

1. Canvassing by any participant, in any form, will render its disqualification.
2. The Hon'ble Court reserves the right to reject any QUOTATION of a participant whose past performance has been held unsatisfactory and/or which has been delinquent and/or which has been negligent in performing its duties thereby jeopardizing the interests of the Hon'ble Court, and in this regard, the decision of the issuing authority will be final.
