2. Quotations should be submitted in sealed envelope with **CM/08/20-21** superscripted in it.

3. Rates should be quoted indicating price / unit and should be inclusive of all additional taxes/charges.

4. Willing suppliers submitting Quotations should know that the Hon'ble Court may procure <u>such quantity of listed</u> <u>articles</u> as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Admn.)
