- Quotations should be submitted in sealed envelope with  ${\it CM/10/20-21}$  superscripted in it.
- Rates should be quoted indicating price / unit and should be inclusive of all additional taxes/charges.

  Willing suppliers submitting Quotations should know that the Hon'ble Court may procure **such quantity of listed** articles as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Admn.)
