- 2. Quotations should be submitted in sealed envelope with CM/03/22-23 superscripted in it.
- 3. Rates should be quoted indicating price / unit and should be inclusive of all additional taxes/charges
- 4. Willing suppliers submitting Quotations should know that the Hon'ble Court may procure **such quantity of listed articles** as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Admn.)-in-charge, High Court, A.S. Calcutta.
