- Quotations should be submitted in sealed envelope with **CM/33/23-24** superscripted in it.

  Rates should be quoted indicating price / unit and should be inclusive of all additional taxes/charges.

  Willing suppliers submitting Quotations should know that the Hon'ble Court may procure **such quantity of listed** articles as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Admn.), High Court, A.S. In case of any deviation from this and any default regarding this on the part of a selected supplier, the administration of this Hon'ble Court may take any or all such actions including cancellation of the work order
- against the supplier as it may consider appropriate.
