**NOTICE**

The following arrangements for disposal of only extremely urgent matters by the Vacation Bench during the ensuing **Christmas Vacation 2017** commencing on and from **25th December, 2017 to 1st January, 2018** are notified for general information.

**DIVISION BENCH**

The Hon'ble Justice **Sanjib Banerjee** and The Hon'ble Justice **Protik Prakash Banerjee** will sit together on **28.12.2017 in Court Room No. 8** and take only urgent matters relating to Civil, Writ and Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

**SINGLE BENCH**

The Hon'ble Justice **Debi Prosad Dey** will sit singly on **26.12.2017 in Court Room No. 7** and take only urgent matters relating to Civil, Writ and Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

The Hon'ble Justice **Siddhartha Chattopadhyay** will sit singly, on **26.12.2017 in Court Room No. 6** and take only urgent matters relating to Civil, Writ and Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

The Hon'ble Justice **Md. Mumtaz Khan** will sit singly, on **28.12.2017 in Court Room No. 7** and take only urgent matters relating to Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

The Hon'ble Justice **Rajasekhar Mantha** will sit singly, on **28.12.2017 in Court Room No. 6** and take only urgent matters relating to Civil, Writ and Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

**NOTE :**

1. The sitting of Benches (both Division and Single) will be from **10:30 a.m. to 1:15 p.m. and from 2 p.m. to 4-30 p.m.**
2. If any matter is released by any of the Single Bench(es), the same will be heard by the other available Single Bench(es).
3. During the entire **Christmas Vacation, 2017** there will be a skeleton staff on duty for allotting permanent numbers. No matter without permanent number will be ordinarily entertained.
4. No matter shall ordinarily be entertained at the residence of the Hon'ble Judges.
5. In the absence of The Hon'ble The Chief Justice, the senior most Judge available in town shall exercise the determining power during the **Christmas Vacation.**
6. All applications to be moved in Court should be filed with Form - "A" and/or "B" mentioning the Court No. along with the name/names of the Hon'ble Judge/Judges positively.
7. Affidavits may be sworn in at the Court premises from 10-00 a.m. on the above mentioned days only.
8. Two Commissioners of Affidavit are to be present by 10:00 a.m. on each and every working day (except executive holidays, as per roster) and to remain present in office till completion of Court business.
9. The Criminal Section will remain open on all the days mentioned above for the conduct of urgent works.

For the ensuing Christmas Vacation, 2017, I do hereby determine that on and from 25th December, 2017 to 1st January, 2018, Civil, Criminal and Constitutional Jurisdictions both Appellate Side and Original Side of the High Court at Calcutta shall be exercised, in accordance with the Rules of the High Court (Appellate Side and Original Side), Calcutta in the following manner :-

**On 26th December, 2017**

The Hon'ble Justice Debi Prosad Dey

Will sit singly and take only urgent matters relating to Civil, Writ and Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

The Hon'ble Justice Siddhartha Chattopadhyay

Will sit singly and take only urgent matters relating to Civil, Writ and Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

**On 28th December, 2017**

The Hon'ble Justice Sanjib Banerjee

And

The Hon'ble Justice Protik Prakash Banerjee

Will sit together and take only urgent matters relating to Civil, Writ and Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

The Hon'ble Justice Md. Mumtaz Khan

Will sit singly and take only urgent matters relating to Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

The Hon'ble Justice Rajasekhar Mantha

Will sit singly and take only urgent matters relating to Civil, Writ and Criminal Jurisdictions filed during vacation or with leave of the Regular Bench.

If any matter is released by a Division Bench on the personal ground of either of the Hon'ble Judges comprising the Bench or the order impugned is passed by a member of such Bench, then the same shall be taken up by the Bench comprised of the seniormost Judge holding vacation Court on a particular day together with the other member of the Bench which released such matter.

If any matter is released by any of the Single Benches, the same shall be heard by the other available Single Bench(es).

No matter shall ordinarily be entertained at the residence of the Hon'ble Judges.

In the absence of the Hon'ble Chief Justice, the senior-most Judge available in town shall exercise the determining power during the Christmas Vacation.
