This system will come into effect from 1<sup>st</sup> August, 2015. The vendors willing to purchase cause list from the month of August, 2015 and onward are hereby directed to deposit the subscription for those months positively within 10<sup>th</sup> day of the same months. For example, the vendors, willing to purchase cause list for the month of August, 2015 must make payment within 10<sup>th</sup> day of August, 2015 and the vendors, willing to purchase cause list for the month of September, 2015 must make payment within 10<sup>th</sup> day of September, 2015 and so on.
