For example, the vendors, willing to purchase cause list for the month of August, 2015 must make payment within 10<sup>th</sup> day of August, 2015 and the vendors, willing to purchase cause list for the month of September, 2015 must make payment within 10<sup>th</sup> day of September, 2015 and so on.
