The undersigned has been directed to inform that henceforth all the vendors, purchasing daily/monthly cause list are required to pay cost thereof for every month within 10<sup>th</sup> day of the same month. ## **Annexed Sheet**

1. The consolidated list of properties as mentioned in Annexure 'G' in the plaint is not found. Moreover Annexure 'G' can not be recognised as 'Mittal Settlement'. So without the schedule of properties, Decree of Partition can not be drawn up. Thus the ground on which the settlement of this Decree could not be done previously, is not clarified even today.

2. APO No. 555 of 1992 as mentioned in the paperbook does not tally with the Judgment dated 22.05.1997 as the number mentioned in the Judgment is APO No. 555 of 1995.

3. In the Judgment dated 22.05.1997 by The Hon'ble Justice Ruma Pal And The Hon'ble Justice Devendra Kumar Jain (as their Lordships the then were), the cause title mentioned as "Vinod Kumar Agarwal" in APO No. 504 of 1992 and Binod Kumar Agarwal" in APO No. 555 of 1992 – Please clarify whether they are same person or not.

4. There is no specific order of devolution of shares allotted to the original Appellant no. 1, Dedraj Chowdhury, upon the substituted Appellant Kusum Agarwalla. So it may be clarified that in the body of the Decree, whether the name of Dedraj Chowdhury or Kusum Agarwalla will be remained.

5. In terms of Order dated 15.03.1993 of The Hon'ble Supreme Court (As appearing in Page – 6 of the Judgment dated 22.05.1997) Clause – ( c ), (e) and (g) of the order under Appeal stood deleted. But from the second paragraph of the order dated 14.10.1993 passed by The Hon'ble Justice Ajit Kumar Sengupta and The Hon'ble Justice Nure Alam Chowdhury (as their Lordships the then were), it appears that the arrears will be paid in terms of the order of The Hon'ble Apex Court which is apparently lying in the contrary with the Clause – (g) (Page no. 6 of the Judgment dated 22.05.1997) – please clarify.

6. In terms of the order dated 18.11.1993 passed by The Hon'ble Justice Ajit Kumar Sengupta and The Hon'ble Justice Nure Alam Chowdhury (as their Lordships the then were), there is a reference of "Terms of Settlement". But there is no reference of Terms of Settlement in the case file. Moreover the Terms of Settlement has not been filed, as it appears from the case records. Please clarify.

7. In terms of order dated 17.12.1993 passed by The Hon'ble Justice Ajit Kumar Sengupta and The Hon'ble Justice Nure Alam Chowdhury (as their Lordships the then were), the second paragraph tells about a list of document in respect of all the properties with whosoever they maybe lying. But there is no such list found in the case records.

Pursuant to the direction of The Hon'ble The Chief Justice dated 8<sup>th</sup> December, 2021 His Lordship has been pleased to direct as follows:
