Link will be sent to the Learned Advocate/Party-in-person in cluster and will let them join in VC, one item prior to their matter, in order to prevent any kind of disruption in Court proceeding. (If the link is not received in the **Inbox**, Ld. Advocates are requested to **check spam folder** of their respective emails.)

In this regard, Learned Advocate/Party-in-person are requested to follow the Display Board-Jalpaiguri of Calcutta High Court to ascertain the running serial of the respective Hon'ble Benches, which is available at <https://www.calcuttahighcourt.gov.in/Display-Board-Jalpaiguri-New>

Learned Advocate/Party-in-person are requested to keep their microphone muted except while interacting with the Hon'ble Bench.
