**Note 1 :** Public Holidays on account of New Year's Day (January 1<sup>st</sup>), Second day of Laxmi Puja (29<sup>th</sup> October) and Kali Puja (12<sup>th</sup> November) fall on Sundays.

Note 2 : Public Holiday on account of Mahalaya (October 14th) falls on Second Saturday.

**Note 3** : Holidays on account of Muslim Festivals viz. Id-ul-Fitre, Id-uz-Zoha (Bakrid) and Muharram will be declared later on, depending on visibility of the moon.

**Note 4** : Sectional Holiday on account of Sab-e-Barat (March 8<sup>th</sup>) falls on Wednesday may be granted to Muslim employees. Sectional holiday on account of Mahabir Jayanti (April 4<sup>th</sup>) may be granted, when possible, to the Jain employees. Sectional holiday on account of Baisakhi (April 14<sup>th</sup>) coincides with the Chaitra Sankranti falls on Friday.

**Note 5** : The Court and Offices of the Judgeship of Darjeeling & Kalimpong shall remain closed on 13.07.2023 (Thursday) on account of the Birthday of the Nepali Poet Bhanu Bhakta.

**Note 6**: All the District Judges in West Bengal, Chief Judges of the City Civil Court at Calcutta, City Sessions Court, Calcutta and the Chief Metropolitan Magistrate, Calcutta are hereby empowered to declare local holidays not exceeding two days in a year in a district and/or Sub-Divisions according to the prevalent customs in consultation with the local Bar Associations.

**Note 7**: All 2<sup>nd</sup> and 4<sup>th</sup> Saturdays of the months have been declared as holidays for the Subordinate Civil & Criminal Courts in West Bengal Vide F.C. Resolution dated 06.08.92.

**Note 8** : The Courts in the Districts of Darjeeling & Kalimpong, excepting the Courts in Siliguri Sub-Division under Darjeeling Judgeship shall have no Summer Vacation unlike that of all other Districts of West Bengal.

**Note 9**: In the districts of Darjeeling & Kalimpong, the Courts excepting the Courts in Siliguri Sub-Division of Darjeeling shall be closed for Durga Puja to Laxmi Puja during the Executive holidays from October 20<sup>th</sup> to 28<sup>th</sup> October and Bhatridwitiya (November 15<sup>th</sup>). The Courts in the districts of Darjeeling & Kalimpong shall also be closed for Annual Vacation for the period from the 2<sup>nd</sup> January to 26<sup>th</sup> January and 25<sup>th</sup> December to 31<sup>st</sup> December, 2023 excepting the Courts in the Siliguri Sub-Division in the District of Darjeeling which shall be closed for Annual Vacation as in the District of Jalpaiguri.
