They are also requested to bring their original call letter for Personality Test/ Viva-voce Test as well as Admit Card for the preliminary examination (held on 17/03/2019) and original photo identity proof (i.e. Voter Card and Aadhar Card etc., original age proof (like birth certificate, Admit card of Madhyamik Examination etc.) and also all the original testimonials regarding their educational qualification, as well as other qualification certificate, sports category certificate, caste certificate, EC certificate, if any, for their documents verification along with self attested photocopies of the aforesaid documents.

They have to report at the English Department, District Judge's Court, Hooghly positively within 12:00 Noon as per schedule mentioned above. If any candidate fails to submit requisite documents as per his/her application, his/her candidature will be treated as cancelled at the time of verification of documents.

Call letters for Personality Test/Viva-voce Test will be dispatched very shortly. It is pertinent to mention here that candidate has to log in by entering his/her application number and password (generated at the first time of Registration) and then he/she will be able to download his/her admit card.
