INSTRUCTIONS FOR CANDIDATES LISTED IN THE LIST ANNEXED HERETO

- 1) The Interview Venue will be at the District Judges' Court Compound at Krishnagar, Nadia.
- 2) The Reporting Time of the Candidates at the Interview Venue will be at 12:30 P.M.
- 3) Candidates are requested to note the Date of Interview against their names in the Concerned List.
- 4) CANDIDATES MUST BRING BOTH THE COUNTERPARTS OF THEIR ADMIT CARDS RETAINED BY THEM AFTER THE EXAMINATIONS HELD ON 17.11.2019 & 22.12.2019.
- 5) Candidates must bring at least one of the following Original (not photocopy or scanned copy) valid photo identification proofs (Passport, PAN Card, Voter Identity Card, Aadhar-UID Card, Driving Licence) at the Interview Venue with a photocopy thereof for verification by Venue Officials.
- 6) Candidates will be permitted to appear at the Interview ONLY after their credentials are verified by Venue officials.
- 7) Candidates are advised to reach the Interview Venue positively before the scheduled Reporting Time noted above. No candidate shall be allowed to report at the Interview Venue after 15 minutes of the scheduled Reporting Time.
- 8) The candidates MUST BRING all original documents which they uploaded while making the application (in support of their date of birth / age, educational qualification, caste, disability certificate, special category or special skills etc. as applicable) ALONG WITH LEGIBLE PHOTOCOPIES THEREOF.
- 9) The identity of the candidates and the documents uploaded by them during making the applications shall be verified by authorized officials at the Interview Venue and only after due verification thereof, the candidates will be permitted to appear before the Interview Board.
- 10) Failure to strictly follow any of the above instructions shall result in cancellation of the candidature.
