**→ Medical examination of the candidates will be held on the following day of the date mentioned against their names.**

→ The protocol for medical examination of candidates is mentioned below:-

1. Selected candidate will have to submit Rs.25/- (twenty five) only by T.R.-7 obtaining prior permission from CMOH from 02/07/2018 onwards [as per the stipulated day mentioned against their name].
2. After deposition of the T.R.-7 the candidates will report to Superintendent, District Hospital on the next day at 09.30 a.m. They will undergo examination by different specialist and at the end of the day will bring the reports of the CMOH.
3. At the office of the CMOH they will have to deposit Rs.75/- (seventy five) only per head and will collect the medical report in the evening.
4. Medical certificates shall be issued from the office of the CMOH at 5.00 p.m. onwards.
5. Medical certificates issued by the CMOH Office are to be deposited on the same day at the English Department of this Judgeship.
6. Duly filled in P.V.R. Form are to be deposited at the English Department of this Judgeship within five days from the date of collection of the P.V.R. Form.
