Applications are invited in prescribed format, from eligible and willing Learned Advocates, practicing ordinarily in the High Court, Calcutta for empanelment in **Category-A** (over 20 years of practice), **Category-B** (10-20 years of practice) & **Category-C** (3-10 years of practice) Panels of Ld. Advocates of this authority, whose services would be made available to eligible persons seeking legal aid from the HCLSC under the National Legal Services Authority (Free & Competent Legal Services) Regulations, 2010. Existing Panel lawyers may fill '**Option Form**', available at the front-office of HCLSC, if they wish to continue in their respective Categories; however, they would be required to apply afresh, in the given format, if they wish to be considered for empanelment in a different category.

Applicants may kindly note that completed applications, typed and duly signed by them in the enclosed format, and accompanied by self-attested copies of documents supporting the entries therein and their passport size photographs (2 copies), will only be considered by the authority.

The period of practice would be calculated from the date of enrolment of the applicant to the date of this notice, and the applicants may submit a separate list of cases (with numbers/ cause-title/ nature of case) conducted by them, while mentioning their practice details.

Completed applications in sealed envelope, addressed to '**The Secretary, High Court Legal Services Committee, High Court, Calcutta**' would be received, by post or by hand, only upto **5 pm on 02 February, 2018** at the office of the HCLSC at the above mentioned address.

Applicants may kindly note that incomplete applications would not be entertained and that merely applying would not entitle them to such empanelment, and the decision of the competent authority would be final in that regard.
