The constitution of the following Benches at Jalpaiguri is hereby notified for information of all concerned:

### **Circuit Bench of Calcutta High Court at Jalpaiguri**

The Hon'ble Justice Shivakant Prasad, the Hon'ble Justice S.B. Saraf and the Hon'ble Justice Hiranmay Bhattacharyya will hold the Circuit Bench at Jalpaiguri on and from Monday, the 15<sup>th</sup> February, 2021 till Friday, the 26<sup>th</sup> February, 2021 (both days inclusive), in the following manner:

Hon'ble Justice Shivakant Prasad And Hon'ble Justice Hiranmay Bhattacharyya	<b>DB - I</b>	Will take all matters required to be taken up by a Division Bench.
Hon'ble Justice Shivakant Prasad	<b>SB - I</b>	Will take up matters required to be taken up by a Single Bench. And Matters relating to Arbitration & Conciliation Act, 1996 including applications connected thereto.
Hon'ble Justice S.B. Saraf	<b>SB - II</b>	Will take up matters required to be taken up by a Single Bench.
Hon'ble Justice Hiranmay Bhattacharyya	<b>SB - III</b>	Will take up matters required to be taken up by a Single Bench.

Note : Commencement of sittings of the Benches will be decided by the Hon'ble Judges holding the Circuit Bench.

If any matter is released by the Division Bench of which Hon'ble Justice Shivakant Prasad is a member, on the ground of Hon'ble Justice Shivakant Prasad, the same shall be heard by a Division Bench comprising Hon'ble Justice S.B. Saraf and Hon'ble Justice Hiranmay Bhattacharyya. Similarly, if any matter is released by the Division Bench of which Hon'ble Justice Hiranmay Bhattacharyya is a member, on the ground of Justice Hiranmay Bhattacharyya the same shall be heard by a Division Bench comprising Hon'ble Justice Shivakant Prasad and Hon'ble Justice S.B. Saraf.

Appeals against the order of Hon'ble Justice Shivakant Prasad shall be heard by the Division Bench comprising Hon'ble Justice S.B. Saraf and Hon'ble Justice Hiranmay Bhattacharyya. Similarly, appeals against the order of Hon'ble Justice Hiranmay Bhattacharyya shall be heard by the Division Bench comprising Hon'ble Justice Shivakant Prasad and Hon'ble Justice S.B. Saraf.

If any matter is released by a Single Bench, the same shall be heard by the other available Single Bench.

The directions issued vide Notification No.4286-RG dated 27<sup>th</sup> November, 2020 shall be followed as far as practicable.

The directions issued vide Notification No. 111-RG dated 8<sup>th</sup> January, 2021 shall be followed strictly.
